


Projected Revenue by Fund Source

The text description for the above chart is as follows: The total revenue projected for Aspire Berkley Maynard Academy is \$8,955,666.00, of which \$6,066,193.00 is Local Control Funding Formula (LCFF), \$1,854,077.00 is other state funds, \$55,011.00 is local funds, and \$980,385.00 is federal funds. Of the \$6,066,193.00 in LCFF Funds, \$1,442,200.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.



Of that amount, \$1,443,250.00 is tied to actions/services in the LCAP and \$7,949,385.00 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

General fund budget expenditures not included in the LCAP are divided into two main categories - salaries & benefits, and operating. Salaries & benefits are included for the following positions: core teachers, specialist teachers (those not highlighted in the LCAP), instructional assistants, special education, after school program, campus operations (including front office, administration, facility, and cafeteria), substitute teachers, and stipends. Operating expenses are included, but not limited to, the following: education and physical education materials, conferences & travel, education consultants, professional services, field trips, rent, utilities, food services, management fees (national office, regional office, authorizer, SELPA), insurance, interest, depreciation & amortization, and contributions to reserves.

### Increased or Improved Services for High Needs Students in the LCAP for the 2022 – 23 School Year

In 2022 – 23, Aspire Berkley Maynard Academy is projecting it will receive \$1,442,200.00 based on the enrollment of foster youth, English learner, and low-income students. Our core values of Well-Being, Culture of Belonging, Community Partnership, Agency and Self Determination, and Joy bring our Vision to life and drive our actions each day including obtaining feedback from our educational partners. We routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners’ beliefs that guide our efforts from high-level perspectives to targeted recommendations. All priorities and goals, including LCAP goals and additional funding, were developed within the context of our core values. With additional funding, our needs remain the same but now we can increase efforts through intensity and or frequency.

Specifically, we met with our educational partners, families, staff, administrator group in June, July, August and September 2021 as we prepared to return to in-person learning. Our focus groups discussed safe, in person learning and ways to mitigate learning loss. Our educational partners emphasized the need to support related LCAP actions by increasing personnel to ensure the safety and well-being of staff and students. We funded additional positions for instructional support that provide interventions to increase English language proficiency, reading, mathematics, address social emotional needs, and arts education for all students. Again, we meet regularly with our educational partners through several venues to monitor our efforts and gather feedback.

Our vision and core values are at the heart of all conversations. As additional funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents, and community members.

Additional staff will accomplish the following.

1. Increase personnel to
  - increase the intensity and frequency of interventions for our students through additional certificated and classified personnel
  - increase access to tutoring
  - expand summer school
  - provide wrap-around services
2. Increase mental health supports for students, staff and families through
  - counselors, psychologists
  - transition supports for elementary to middle to high school,
  - improved social emotional curriculum
  - increased access to mental health services
  - social emotional professional development
3. Increase professional development
  - instructional coaching through additional site administration
  - strengthen core instruction curriculum
4. Ensure facilities serve students optimally through
  - additional custodial staff hours
5. Increase collaboration with outside organizations to assist with
  - services to students and families around mental health
  - train staff in curriculum, SEL and academic

As noted earlier, we routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners' beliefs that guide our efforts from high-level perspectives to targeted recommendations. Since the pandemic began, we have focused on physical and emotional safety for our students. Throughout this emergency response, we surveyed families (March 2021), conducted virtual meetings with ELAC (March 2021), PAC (August 2021), students (August 2021), staff (May and June 2021), and administration (June through August 2021) and corresponded via web-based tools as we prepared to return to in person learning. Our focus groups, listening meetings, and safety talks resulted in articulating the impact of distance learning on families, students, and staff including social emotional issues as well as academics.

It was especially important to ensure our community felt safe returning to in-person instruction. We knew from multiple meetings that our community members were impacted emotionally by the conditions of virtual learning and the pandemic itself. We dedicated time and financial support for increased access to mental health services via counselors, psychologists, outside agencies, and family resources. We worked to mitigate student learning loss through additional support staff, reducing class size and/or decreasing small group ratios by hiring two Literacy Interventionists, investing in Reading Partners, and also a SEEEDS IA. As a school, we invested in SIPPS curriculum and training to provide Tier 2 and 3 supports to our students 2 or grades behind in reading and for our students with disabilities. Lastly, to increase joy and play and social development during recess, we partnered with Playworks to hire a full time coach.

We built a strong distance learning program in SY 20-21 that prioritized social emotional learning, literacy instruction, and small group learning sessions in order to differentiate for student needs. We also built a strong attendance intervention program to support our students and families with class attendance over distance learning. All of our staff and students were provided with the necessary tools to engage in distance learning.

Thanks to the communication and structures we adopted during distance learning, we maintained a comparable attendance rate. We were able to continue communication efforts seamlessly when we returned to in-person instruction and engage our school community continuously. As funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, and families. Additionally, distance learning required that we learn, use, and implement technology to enhance instruction. When we returned, we maintained technology tools that enhance in-person instruction and provide consistent intervention, e.g. SIPPS, etc.

Despite additional funds, the most challenging area is staffing. It is difficult to hire for critical areas already in short supply. Returning to in-person instruction makes it more difficult. The availability of qualified personnel is limited, and many people are hesitant to return to the workforce, thereby reducing the pool of candidates.

Additionally, the substitute pool was difficult pre-pandemic for all districts. The situation is exacerbated by an increase in pandemic related absences. When staff members or their family members get covid, absences are extended until it is safe to return.

As a result, it is difficult to bring some actions to scale, e.g. provide interventions systematically. Consequently, we delineated a timeline of spending funds over the three years allotted. This first year will focus on academic learning loss, social emotional issues, and partnering with educational organizations for temporary support. Once we are post pandemic, we are hopeful that staffing difficulties will be resolved and we can hire qualified staff more easily.

## Plan Summary 2022-23

### General Information

Aspire Berkley Maynard Academy is a direct-funded charter school in Northwest Oakland. It is chartered through Aspire Public Schools. The school is designed to serve approximately 545 students in grades Transitional Kindergarten to 8th grade. The school’s demographic profile is 31% Latino, 58% African-American, 2% Asian-American, 3% Caucasian, 6% Two or More Races, and 13% English Language Learners with 72% of the student body eligible for the free and reduced price meals program.

Berkley Maynard Academy is part of the non-profit Aspire Public Schools (APS). Aspire serves Berkley Maynard Academy through business services, professional development and other operational support. Aspire’s vision is that every student is prepared to earn a college degree and was founded to address the long-standing inequities in TK-12 education. Its mission is to open and operate small, high-quality charter schools in low-income neighborhoods in order to: increase the academic performance of historically underserved students, develop effective educators, share successful practices with other forward-thinking educators, and to catalyze change in public schools.

Specifically, at Berkley Maynard Academy, our mission is to foster, support, and develop a learning environment in which scholars are healthy, safe, loved, supported, and challenged socio-emotionally and academically. We are a community of lifelong learners who believe in working together, with parents and our greater community, to provide students access to and through college.

Aspire Berkley Maynard Academy is dedicated to preparing all of our students for the opportunity of college and /or career success. Everything about Aspire Berkley Maynard Academy from the college flags in our hallway to our data-driven rigorous instruction — is designed to put our students on the road to higher education. Helping our students realize the college dream is a challenge that requires the hard work of every member of our school family: our students love learning and achieve amazing results; our staff is the hardest-working group of professionals in the business; our parents and families are involved in supporting every aspect of our college-going culture; and our community partners, volunteers and supporters enable us to meet the unique needs of our students and our community.

## Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Throughout this school year, our school provided a comprehensive instructional program and instructional minutes covering Humanities, Math, Science, Social Justice, and Social Emotional Learning. Students received at least two 30 minute blocks weekly to address Social Emotional Learning through our RULER curriculum. In response to the data of our African American student population dating back to our SBAC results in 2019, we identified “focal” students that received at least two 30 minute blocks of literacy interventions per week with their general education teacher. Focal students were identified based on a diagnostic screener (STAR ELA) and interventions were provided to African American students who were at least one year or more behind scoring level for their grade benchmark. Approximately 125 African American students received one hour of direct, grade level literacy intervention to support their growth. Teachers celebrated growth and continued to monitor progress, adjust groupings, and meet their students' needs in literacy at the beginning and end of each quarter.

## Reflections: Identified Need

This year, we worked to address chronic absenteeism during our distance learning program. As a means to support teachers, families, and students with access to their online, virtual learning program, we ensured that every single classroom teacher had a co-teacher to support getting online, connected, navigating classwork, and communicating with families. We had improved from the 18-19 school year of 17% of students chronically absent. Our rate significantly increased from 7% last year to 14.3% during our full distance learning program this year. As we are reopening, we plan to continue to address working with families directly, creating attendance plans to ensure students have access to the full day of in person programming, and that we address needs for any remote access to our school.

## LCAP Highlights

We are looking forward to continuing the progress we made this year returning to full in school programming. As we continue to support our scholars, we will continue to need additional support in the areas of academic intervention, social emotional learning, and community building. We plan to support student academic acceleration through use of research based intervention curriculum named SIPPs, leveraging additional instructional aides, and piloting new Aspire instructional guidelines for mathematics. We plan to continue our strong social emotional learning program and will continue to use the Ruler 2.0 to guide our instruction. We are planning to hire an additional mental

health counselor to support our students' wellness. We will continue to prioritize the recruitment, development, and retention of staff that are aligned with our vision of rigorous and culturally relevant education for all students.

# Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

At Aspire Berkley Maynard Academy, we believe in connecting with families, students, staff and community stakeholders to create two way dialogue about the priorities we focus on as a school, the allocation of budget and resources to support those priorities, and measurement/progress monitoring of our goals to ensure their is collaboration and accountability on growth for our students.

Throughout our LCAP development process, we consulted with the multiple stakeholder groups including our administration, instructional leadership team, classified and certificated staff, students, and families.

The LCAP engagement sessions began in October with our leadership team about our areas of focus and priorities. We determined that returning from a pandemic the following year would require an acute focus on literacy instruction and our Multi-tiered systems of support. Families participated in providing feedback about their hopes, dreams, and needs with reopening the following school year through a Black Parent Union Meeting (BPU) on Wednesday, March 17th. We also engaged our entire school community through a Town Hall meeting on April 28th.

Students were polled and responded to surveys in February (our 3rd through 8th graders. Our entire teaching community also engaged in feedback during their weekly team meetings and captured their feedback on our priorities for next year in partnership with their instructional teacher leaders the month of May.

We routinely engage with our SELPA through our special education manager to ensure students with disabilities are appropriately represented in the LCAP.

A summary of the feedback provided by specific educational partners.

Beginning with the staff members, teammates were focused on wanting to be grounded in core, rigorous literacy practices and the social-emotional well-being of our students returning from a pandemic. Families also shared the same hopes and dreams as well as wonderings and hopes around physical safety. Safety protocols, mental health supports, and academic interventions were the most important components of our program next year for families.

From the feedback above, our LCAP was influenced in the following ways:  
Restructuring to support Student Wellness through School Support Managers  
- Addition of Literacy Interventionist for 1st and 2nd grade

- Addition of Playworks for recess joy and safety as well as extracurriculars through play.
- Hiring of additional instructional aides for younger grade classrooms.
- Purchase of and training on the use of the SIPPS curriculum for tier 2 and 3 reading intervention.
- An addition of a 2nd mental health counselor

As we returned to re-opening for the school year 2021 - 2022, it was vital that we focused on in-person instruction that is not only rigorous, but standards aligned and culturally responsive in order to accelerate learning for our scholars. Throughout the 2020-2021 school year, we heard from our stakeholders that when we return to in-person instruction, scholars will need extra support to accelerate learning from a year of online instruction. ## Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were pleased with our professional development and training sessions. Despite a mix of in-person and virtual instruction, our staff accessed training virtually and we were able to accomplish most of our PD and training plans for MTSS, standards-based instruction, data analysis, collaborative planning, integrated ELD, anti-racism, classroom management, and the science of reading.

Continued training, whether virtual or in person, was successful as evidenced by an increase in local assessments that increased 15% on average from beginning-year to mid-year outcomes despite conditions due to Covid. Still, Covid disrupted schedules for integrated and designated ELD as well as systematic interventions for all students. For safety reasons, we were unable to combine cohorts of students into designated ELD programs and provide systematic interventions in a consistent way.

Additionally, purchasing curriculum, technology, and intervention materials in 2021-22 proved to be beneficial. Despite a lack of personnel for in-person instruction, we believe the added materials mitigated student learning loss. Still, like all districts throughout the country, we experienced staffing issues. To address staffing challenges, we provided stipends, common plan time, and extended hours as alternatives to hiring new staff. Our continued use of Wit and Wisdom and Eureka Curriculum along with prioritizing common planning time for teachers has had a positive impact and we believe that it has mitigated further learning loss.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

As noted in Prompt 1, we experienced difficult staffing issues, most notably the two instructional assistant positions and with many staff absences related to COVID quarantine and exposure. Consequently, we directed those funds to additional actions and provided stipends (Action 1.7) for existing teachers and extended hours for classified staff. The difference between budgeted and estimated actual expenditures, therefore, was limited and consequently, so was the difference between planned and estimated actual percentages of improved services.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, provided the means to partially meet our goal of all “scholars meaningfully engaged in rigorous, standards-aligned, culturally responsive academic programming”. We provided multiple curriculum materials to meet the varied needs of our students. We renewed classroom libraries with culturally representative books, infused technology for seamless curriculum delivery, and ensured just-in-time interventions with targeted materials, SIPPS, Wit & Wisdom, Eureka Math and assessment monitoring using iReady, SIPPS mastery tests, and DIBELS. Implementing varied materials enabled us to fully realize academic content, provide full access to CCSS and ELD materials for English Learners, and ensure all students engaged with standards aligned materials.

Ensuring effective staff also ensures student learning. Staff members engaged in professional learning to optimize the curriculum materials noted above as well as MTSS, standards-based instruction, data analysis, collaborative planning, integrated ELD, anti-racism, classroom management, and the science of reading. Whether we were in-person or virtual, we were able to meet our professional development actions.

Staffing was difficult this year. We planned to hire instructional assistants and AmeriCorps members to support our students and teachers. A national staffing shortage exists and we were not immune from that. We met our staffing actions with limited success. Consequently, we plan to focus on temporary hires, partner with education organizations, hire an interim Dean of Instruction to provide additional coaching to teachers, and increase technology-enhanced instruction.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

While we met with minimal success during a very difficult year, we realize there are changes to be made. We added Action 1.9 for progress monitoring and Action 1.10 with an expectation that we shift our general professional development in NGSS to specifics of best practices in content areas for MLLs.

### Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Covid has continued to cause unprecedented disruptions to school operations, particularly in the area of culture and climate. While we have returned to in person instruction, covid quarantines have removed the predictability and consistency that have historically been pillars of our school model. Additionally, we have been unable to host large group gatherings and community building events for our school community. While we have done our best to hold these events online through zoom, participation has been significantly lower than in previous years.

The above has had a significant impact on student social emotional wellbeing as evidenced by an increase in mental health needs and maladaptive behavior and decreases in attendance. These areas have taken greater priority and have required more intense efforts that we initially planned for. Students struggled with Covid conditions and often came to school having been personally impacted by Covid deaths or exposures. We increased social emotional learning time, further committed to our school wide mindfulness initiatives, and reallocated staff to focus on supporting student supervision during unstructured times like recess and lunch.

We struggled to maintain a robust MTSS program on our campus due to staffing shortages and the need for on campus administrators to cover classes and cover positions that were out on covid quarantine or unfilled.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between budget and estimated actual expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, support goal 2, to cultivate communities that foster inclusive, joyful, and safe learning environments. Quantitatively, our attendance rate decreased from 96.3% to 90.9% (As of April 9) and our chronic absenteeism increased from 13.3% to 30.1%. Covid conditions directly contributed to our level of attendance and chronic absenteeism. Parents cited Covid as the reason for their child's absence and we monitored return dates per CDC guidelines when students were absent due to Covid.

From our LCAP survey, we saw the following: despite Covid complications throughout the year, student, staff and parent surveys indicate a strong sense of belonging and connectedness among families (70%) and a high sense of belonging and connectedness among students (66%). We believe that the decrease in sense of belonging and connectedness among students is due to the inconsistencies that came with staffing shortages and high student absences as a result of COVID. The vast majority (92%) of families reported feeling that the school leadership seeks input when making decisions regarding the school community and 85% of families reported that their children feel safe and welcomed at school.

Due to staffing inconsistencies with staff being placed on covid quarantines, we found that we needed our administration team to focus on covering classrooms and supporting with student safety during recess, lunch, and other unstructured time. Interventions were administered in a less robust way than planned and our MTSS team did not meet as frequently as planned. We were able to examine data quarterly and plan for and implement some intervention services, but we were not able to meet our goal of more thoroughly supporting teachers in thinking through tier 2 supports for their classroom.

Parent and student engagement events were limited, however, on a positive note, we worked to rebuild our school climate and culture with outreach to families and specifically to students via SEL practices. We were able to provide targeted professional development in RULER, social emotional learning, culturally responsive teaching, crisis intervention and restorative practices through virtual training. Additionally, our parent meetings continued, although virtually, for Black Parent Union and we held in person admin coffee chats.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Survey responses indicate a continued need for social emotional learning and more intense counseling. While our MTSS team included a counselor, we believe *two* counselors are warranted given survey responses and ongoing COVID conditions impacting students' well-being. As a result, we revised Action 4, School MTSS Program, to increase our team to two counselors.

We were able to successfully implement all of the above planned actions with the exception of action 1. While we initially planned to host on site affinity groups, the unanticipated mental health needs of staff and students required us to reallocate professional development time to meet those needs. We did prioritize participating in regional affinity groups quarterly.

Virtual training provided a means to continue with professional development, professional learning plans, and coaching. We were able to implement planned actions with no substantive differences in costs for Actions 1-5.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between budgeted and estimated actual expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Our combined actions supported goal 3, “that all scholars have access to a team of diverse, effective, and thriving professionals who are developed and supported to show up their best and enact culturally responsive and anti-racist practices.” Virtual training provided a means to continue with professional development, professional learning plans, coaching, and training specific to certification, e.g. AP training. We maintained focus on the Aspire Student Learning Framework and using Affinity Groups to support collegiality. Our teachers maintained a credential rate of 89% and reported an increased sense of safety and school connectedness.

We continue to pursue our actions in Goal 3 and have not changed goals, metrics, or actions.

Unduplicated funds will be principally directed to low-income and English Learners, the majority of our student body. The student body is 68% unduplicated students, therefore the needs of English learners and low-income students comprise the needs of the majority of our students and represent the focus of our actions. The funds will be effective in increasing and improving the level of academic support and interventions, professional development, data analysis, SEL supports, and continue to build our robust MTSS system. We will use funds to hire and maintain personnel that oversee programs to increase and improve the support systems students receive.

The Actions highlighted in this year’s LCAP are being provided on a school-wide basis and we expect that all students will benefit from the implementation of supports and interventions, PD, support from additional personnel, and the continued implementation and focus on SEL and learning strategies and interventions for our Multi Language Learners.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The minimum proportionality percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all pupils is 30.47%. This proportionality percentage will be met through a combination of targeting the increased LCFF funds towards supports that disproportionately target unduplicated pupils. Each goal’s intent is to focus our services toward our unduplicated

pupils as we believe centering our work on our students furthest from the center will benefit all students. These services are highlighted by principally directing our actions toward our unduplicated populations, which include improving and increasing our intervention and acceleration services, increasing staff to support SEL and well-being, improving our MTSS and PBIS programs, and improving the services provided by our APs, Ed Specialist, Instructional Assistants, Counselors, and Intervention specialists. In addition, Aspire will increase the amount and rigor of the EL professional development provided to teachers enabling all staff to increase their ability to provide a rigorous, culturally relevant, and ELD standards aligned curriculum.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

As noted above, our plan to increase personnel for mental health services and for academic intervention will directly support our students who have increased academic social emotional and academic needs and adverse childhood experiences. This additional staffing will allow us to focus our efforts on students who are learning English, come from a low income household or who are foster youth.

(Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
