


#### Budget Overview for the 2022 – 23 School Year

The text description for the above chart is as follows: The total revenue projected for Aspire College Academy is \$4,998,112.00, of which \$2,192,866.00 is Local Control Funding Formula (LCFF), \$2,091,421.00 is other state funds, \$51,510.00 is local funds, and \$662,315.00 is federal funds. Of the \$2,192,866.00 in LCFF Funds, \$526,742.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Salaries & benefits are included for the following positions: core teachers, specialist teachers (those not highlighted in the LCAP), instructional assistants, special education, after school program, campus operations (including front office, administration, facility, and cafeteria), substitute teachers, and stipends. Operating expenses are included, but not limited to, the following: education and physical education materials, conferences & travel, education consultants, professional services, field trips, rent, utilities, food services, management fees (national office, regional office, authorizer, SELPA), insurance, interest, depreciation & amortization, and contributions to reserves.

Increased or Improved Services for High Needs Students in the LCAP for the 2022 – 23 School Year

In 2022 – 23, Aspire College Academy is projecting it will receive \$526,742.00 based on the enrollment of foster youth, English learner, and low-income students. Our core values of Well-Being, Culture of Belonging, Community Partnership, Agency and Self Determination, and Joy bring our Vision to life and drive our actions each day including obtaining feedback from our educational partners. We routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners' beliefs that guide our efforts from high-level perspectives to targeted recommendations. All priorities and goals, including LCAP goals and additional funding, were developed within the context of our core values. With additional funding, our needs remain the same but now we can increase efforts through intensity and or frequency.

Specifically, we met with our educational partners: school site administrators and staff **June and August** as we prepared to return to in-person learning. Additionally, we met with families after the school year started to gain family input. Our focus groups discussed ways to keep students and staff safe while mitigating learning loss. Our educational partners emphasized the need to support related LCAP actions by increasing personnel, expanding our personal protective equipment and investing in air ventilation and filtration equipment to ensure the safety and well-being of staff and students. We funded additional positions for instructional support that provide interventions to increase English language proficiency, reading, mathematics, address social emotional needs, and arts education for all students. We met with our educational partners through several venues to monitor our efforts and gather feedback.

Our vision and core values are at the heart of all conversations. As additional funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents, and community members.

Additional staff will accomplish the following.

- 1. Increase personnel to increase the intensity and frequency of interventions for our students through additional certificated and classified personnel.
- Increase foundational reading intervention using Systematic Instruction in Phonological Awareness, Phonics, and Sight Words (SIPPs)
  - Investing in SIPPs intervention materials for personal
  - Hiring an on-site substitutes in order to ensure students had consistent adults providing instruction.
  - -Increase access to tutoring during Expanded Learning Program
  - Provide wrap-around services by reestablish Coordination of Services Team (COST)
- 2. Increase mental health supports for students, staff and families through
  - Maintaining a consistent counselors with clinical supervision
  - Contacting psychologists to compensate for backlogged assessments from previous years.
  - -Improved social emotional curriculum Recognizing, Understanding, Labeling, Expressing, and Regulating Emotions (RULER)
  - Increased access to mental health service (3-4 cycles of mental health intervention)
  - Establishing independent study coordinators for students
  - -Continue Mindfulness Life Project partnership and adding family mindfulness sessions.
- 3. Increase professional development
  - Instructional coaching through additional site administration
  - Virtual professional development on iReady reading and math standardized assessment
  - Eureka Math professional development
- 4. Ensure facilities serve students optimally through
  - Expanding our custodial schedule and scope

- Established nightly disinfectant procedures
- Purchased air filters for all classrooms without pre-existing HVAC systems
- Installing mini split units
- 5. Increase collaboration with outside organizations to assist with
  - Weekly COVID-19 testing and communication with families
  - Increase cleanliness and sanitation of building services to students and families around mental health
  - Sourcing COVID-19 RAPID tests
  - Provide external learning opportunities like participating in Expanding Your Horizons (EYH) at UC Berkeley and Oakland Zoo.

As noted earlier, we routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners' beliefs that guide our efforts from high-level perspectives to targeted recommendations. Since the pandemic began, we have focused on physical and emotional safety for our students. Throughout this emergency response, we surveyed families (August 2021), conducted virtual meetings with Families (August 2021), staff and administration in (June, August, October 2021 and January 2022) as we return to in person learning. Our focus groups, listening meetings, and safety talks resulted in articulating the impact of distance learning on families, students, and staff including social emotional issues as well as academics.

It was especially important to ensure our community felt safe returning to in-person instruction. We knew from multiple meetings that our community members were impacted emotionally by the conditions of virtual learning and the pandemic itself. We dedicated time and financial support for increased access to mental health services via counselors, social emotional learning and psychologists. We worked to mitigate student learning loss through additional support staff, reducing class size and/or decreasing small group ratios by increasing the number of staff providing interventions. We also added licenses for online, academic programs, (Lexia, MyOn, Zearn, Reflex, SeeSaw).

A description of how the LEA is implementing the federal American Rescue Plan Act and federal Elementary and Secondary School Emergency Relief expenditure plan, and the successes and challenges experienced during implementation.

We built a strong distance learning program in SY 20-21 that prioritized social emotional learning, literacy instruction, and small group learning sessions in order to differentiate for student needs. We also built a strong attendance intervention program to support our students and families with class attendance over distance learning. All of our staff and students were provided with the necessary tools to engage in distance learning.

Thanks to the communication and structures we adopted during distance learning, we maintained a comparable attendance rate. We were able to continue communication efforts seamlessly when we returned to in-person instruction and engage our school community continuously. As funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents, ELAC, SSC, PAC. Additionally, distance learning required that we learn, use, and implement technology to enhance instruction. When we returned, we maintained technology tools that enhance in-person instruction and provide consistent intervention, e.g. Lexia, Zearn, SeeSaw, Brainpop, Eureka and Wit and Wisdom Sync.

Despite additional funds, the most challenging area is staffing. It is difficult to hire for critical areas already in short supply. Returning to in-person instruction makes it more difficult. The availability of qualified personnel is limited, and many people are hesitant to return to the workforce, thereby reducing the pool of candidates.

Additionally, the substitute pool was difficult pre-pandemic for all districts. The situation is exacerbated by an increase in pandemic related absences. When staff members or their family members get covid, absences are extended until it is safe to return.

As a result, it is difficult to bring some actions to scale, e..g. provide interventions systematically. Consequently, we delineated a timeline of spending funds over the three years allotted. This first year will focus on academic learning loss, social emotional issues, and partnering with educational organizations for temporary support. Once we are post pandemic, we are hopeful that staffing difficulties will be resolved and we can hire qualified staff more easily.

#### **General Information**

Aspire College Academy is a direct-funded charter school in Oakland, CA. It is chartered through the Oakland Unified School District. The school serves approximately 271 students in grades TK-5. The school's demographic profile is 66% Latino, 27% African-American, .4% Asian-American, 3% Other, 0% Caucasian, and 35% English Language Learners. Eighty-six percent of the student body is eligible for the free and reduced price meals program and 12% of our students qualify for special education.

Aspire College Academy is part of the non-profit Aspire Public Schools (APS). Aspire serves Aspire College Academy through business services, professional development and other operational support.

Aspire's vision is that every student is prepared to earn a college degree and was founded to address the long-standing inequities in TK-12 education. Its mission is to open and operate small, high-quality charter schools in low-income neighborhoods in order to: increase the academic performance of historically underserved students, develop effective educators, share successful practices with other forward-thinking educators, and to catalyze change in public schools. Specifically, at Aspire College Academy our mission is to ensure that every scholar in every circumstance leaves Aspire College Academy secondary-ready and on the path to leverage college to find their personal path to success and have a positive lasting impact on their community.

Based on data from the 2021-2022 school year, we see progress as evidenced by our local assessments and we are hopeful SBAC data will reflect that as well. Additionally,

- Scholars received daily SEL lessons as part of their core curriculum
- Successfully engaged with staff on staff-led committees: SEL, Culture and Anti-Racist Accountability Committees to lead the charge on building a stronger, anti-racist school community

- Maintained daily small group intervention for scholars that were falling below grade level in core classes
- Offered daily online and in-person tutoring to scholars and families through our After School program
- Maintained a Coordination of Services Team that led to supporting over 16 scholars to receive tier 3 interventions
- Engaged in outreach efforts to families who received financial assistance through the Aspire Family Relief fund donations and families received fresh fruit and vegetables through our partnership with FoodShift
- Focused the Acute Needs program on reading intervention for scholars reading below grade level in 1st grade and for scholars in grades 2-5 reading at a 1st grade level
- Further strengthened systems and structures for Gen/Ed and SpEd team collaboration which led to increased outcomes for scholars with disabilities, including scholars that require tier 4 level intervention and support.

#### **Reflections: Identified Need**

Based on current data collected during the 2021-22 school year, our English Learners are underperforming as compared to every other student group and our chronic absenteeism (CA) rates rose significantly from 18% in 2021 to 66% in 2022. Our increase is due to Covid conditions that caused extended absences for students, their siblings, and staff. We are cautiously optimistic that our CA levels will drop back to pre Covid levels. Still, we plan to maintain our parent involvement, Goal 2, Action 1. We also plan to strengthen small group instruction for English Learners (Goal 1, Action 1), provide professional development on instructional strategies and follow up with instructional rounds and cycles of inquiry to monitor progress.

## **LCAP Highlights**

The goals outlined in the 2022-23 LCAP are focused on supporting scholars and staff in the transition back to in-person learning. Grounding in school-wide culture and preparing our academic programming to focus on acceleration and gap filling are a major aspect of the priorities for next year. Also outlined is our focus on the inclusion of our scholars with disabilities (SWD) and those in need of English language development (ELD) support. Throughout the 2021-2022 school year, our data showed that our SWD thrived with the increased collaboration between our general and special education teams. Equally revealing in our 2021-22 data, is that our scholars with ELD support needs underperformed in comparison to their peers. Therefore our action plans include continued development of scholars in both of these sub groups.

## **Engaging Educational Partners**

Before finalizing the Local Control and Accountability Plan (LCAP), Educational Partners (EP) engagement played a key role in the identification of progress noted and progress needed in multiple aspects of past and current experiences. Our survey feedback, community forums, committee meetings and ongoing correspondence with parents/family members informed our LCAP. Additionally, we engaged with , certificated & classified staff, principals and district administration, Special Education Local Plan Area (SELPA), and students to hear the collective voices of our partners. Specifically for the purpose of revising the LCAP, additional EP conversations and presentations took place with:

SELPA- We collaborate with our SELPA representatives on a regular basis. Our Charter Operated Program Specialist connects with us on a monthly basis to discuss specific cases, review IEP compliance, explore training opportunities, and understand general updates shared by the SELPA.

We routinely engage with our staff (certificated and classified), students, parents and other educational partners.

#### A summary of the feedback provided by specific educational partners.

Both our Leadership and parent groups identified English Language Learners as a priority to continue to focus on within our LCAP priorities. Our Leadership team identified a need to involve parents more, align instructional practices across grade levels and increase professional development and coaching on ELD standards as action steps to increase academic performance and student engagement.

Although all EP groups expressed general satisfaction with the learning progress for students at Aspire College Academy, EPs recognize that support will continue to be needed for the actions we currently have in place in order to mitigate learning loss and maintain momentum of overall student success in all areas. A common theme across all EP groups was a general concern about the social-emotional needs and mental wellness of students, along with a need for parent education in this area. Consequently, we will intensify our efforts in Goal 2, Action 1, parent involvement. The School Site Council (SSC) and the District English Learner Advisory Committee (DELAC) indicated concern for the general learning loss due to COVID and expressed interest in the district's Multi-Tiered System of Supports (MTSS) and Professional Learning Communities (PLCs) to provide additional intervention as needed.

## Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were able to implement Actions 1-3 but with less intensity. This year we focused on small group instruction, began to align instructional practices across grade levels, and focused on acceleration. Our Actions contained a number of sub actions that came to fruition but less than planned. For example, we planned on monthly teacher led PDs but conducted quarterly PDs, we focused on acceleration and had to prioritize learning loss. For the most part, our professional development activities were accessed virtually. Still, we were able to accomplish most of our PD and training plans but with less intensity or frequency.

We struggled with staffing, specifically hiring Instructional Aides in Action 1. We used funds to advance our goal by extended hours for those already employed, provided stipends, and utilized substitutes strategically.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

As noted in Prompt 1, we experienced difficult staffing issues, most notably with instructional assistants. Consequently, we directed those funds to additional sub-actions with stipends, extended hours and substitutes. The difference between budgeted and estimated actual expenditures, therefore, was limited and consequently, so was the difference between planned and estimated actual percentages of improved services.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, provided the means to partially meet our goal of all "scholars meaningfully engaged in rigorous, standards-aligned, culturally responsive academic programming". We provided a blended learning model that allowed scholars to learn content in a variety of ways. We used exit tickets and quarterly summative assessments to monitor and intervene when necessary.

Our staff worked to align instructional practices across grade levels (Action 2). PLCs met virtually and in person to develop goals at the beginning of a cycle, and our monthly PD was conducted quarterly. Additionally, we worked to align general and special education efforts through a mix of PD, coaching, and leveraging our in-house student learning framework.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

While we met with limited success during a very difficult year, we realize our planned course is the right course of action. Additionally, we shifted our progress monitoring from STAR to iReady as noted in the Measuring and Reporting area. We also revised our EL metrics to reflect the unavailability of ELPI and instead are using the Summative ELPAC.

## **Goal Analysis for 2021-22 LCAP Year**

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Action 2.1 addressed parent engagement. However, Covid caused unprecedented circumstances that prohibited in-person gatherings. While we returned to in-person instruction, our group meetings were restricted. Many of our planned activities became virtual with limited attendance. Action 2.2, to increase school wide joy. We planned to conduct SEL sessions within homerooms, and were able to do so but were unable to coordinate monthly school-wide activities due to Covid. Still, we conducted virtual gatherings, continued homeroom SEL sessions and provided alternative pathways to school-wide activities.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no substantive expenditure differences. The difference between budgeted and estimated actual expenditures was limited and consequently, so was the difference between planned and estimated actual percentages of improved services.

An explanation of how effective the specific actions were in making progress toward the goal.

92% of parents responded Strongly Agree or Agree to the family survey question "I am encouraged to share my opinion and feedback in the school decision making process." 70% this year

Our actions, together, support goal 2, to cultivate communities that foster inclusive, joyful, and safe learning environments. Quantitatively, our attendance rate decreased from 93% to 85% and our chronic absenteeism increased from 6% to 66%. Covid conditions directly contributed to our level of attendance and chronic absenteeism. Parents cited Covid as the reason for their child's absence and we monitored return dates per CDC guidelines when students were absent due to Covid.

Qualitatively, though, our continued efforts to involve parents despite Covid complications, provided opportunities to stay connected. We worked to maintain parent engagement opportunities as evidenced by 74% of parents reporting that the "schools provided opportunities for involvement". In fact, our parents of MLL students reported the highest percent (89%) of agreement when disaggregated.

Still, parents who agreed that they are encouraged to share their opinion and feedback was reduced this year. We credit this reduction to limited opportunities to have robust conversations and are more committed to our planned Actions.

## **Required Descriptions**

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Unduplicated funds will be principally directed to low-income and English Learners, the majority of our student body. The student body is 88% unduplicated students, therefore the needs of English learners and low-income students comprise the needs of the majority of our students and represent the focus of our actions. The funds will be effective in increasing and improving the level of academic support and interventions, professional development, data analysis, SEL supports, and continue to build our robust MTSS system. We will use funds to hire and maintain personnel that oversee programs to increase and improve the support systems students receive.

The Actions highlighted in this year's LCAP are being provided on a school-wide basis and we expect that all students will benefit from the implementation of supports and interventions, PD, support from additional personnel, and the continued implementation and focus on SEL and learning strategies and interventions for our Multi Language Learners.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The minimum proportionality percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all pupils is 37.40%. This proportionality percentage will be met through a combination of targeting the increased LCFF funds towards supports that disproportionately target unduplicated pupils. Each goal's intent is to focus our services toward our unduplicated

pupils as we believe centering our work on our students furthest from the center will benefit all students. These services are highlighted by principally directing our actions toward the needs of our unduplicated populations, which include improving and increasing our intervention and acceleration services, increasing staff to support SEL and well-being, improving our MTSS and PBIS programs, and improving the services provided by our APs, Ed Specialist, Instructional Assistants, Counselors, and Intervention specialists. In addition, Aspire will increase the amount and rigor of the EL professional development provided to teachers, enabling all staff to increase their ability to provide a rigorous, culturally relevant, and ELD standards aligned curriculum.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

As noted above, our plan to increase personnel for academic intervention (1.1) to directly support our students who have increased academic social emotional (2.1) and academic needs due to recent experiences. This additional staffing will allow us to focus our efforts on students who are learning English, come from a low income household or who are foster youth.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [*EC*] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- **Meaningful Engagement of Educational Partners:** The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (*EC* Section 52064[e][1]). Local educational partners possess valuable perspectives and insights about an LEA's programs and services. - d) Held at least one public hearing in accordance with Education Code section 52062(b)(1) or 52068(b)(1), as appropriate.
- e) Adopted the local control and accountability plan in a public meeting in accordance with Education Code section 52062(b)(2) or 52068(b)(2), as appropriate.

### **Goals and Actions**

# **Purpose**

Well-developed goals will clearly communicate to educational partners what the LEA plans to accomplish, what the LEA plans to do in order to accomplish the goal, and how the LEA will know when it has accomplished the goal. A goal statement, associated metrics and expected outcomes, and the actions included in the goal should be in alignment. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
