

The text description for the above chart is as follows: The total revenue projected for Aspire Antonio Maria Lugo Academy is \$8,744,764.00, of which \$4,991,436.00 is Local Control Funding Formula (LCFF), \$2,284,399.00 is other state funds, \$0.00 is local funds, and \$1,468,929.00 is federal funds. Of the \$4,991,436.00 in LCFF Funds, \$1,344,570.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Our core values of Well-Being, Culture of Belonging, Community Partnership, Agency and Self Determination, and Joy bring our Vision to life and drive our actions each day including obtaining feedback from our educational partners. We routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners' beliefs that guide our efforts from high-level perspectives to targeted recommendations. All priorities and goals, including LCAP goals and additional funding, were developed within the context of our core values. With additional funding, our needs remain the same but now we can increase efforts through intensity and/or frequency.

Specifically, we met with our educational partners, ELAC, SSC, staff, administrator group in March and April 2021 as we prepared to return to in-person learning. Our focus groups discussed safe, in person learning and ways to mitigate learning loss. Our educational partners emphasized the need to support related LCAP actions by increasing personnel to ensure the safety and well-being of staff and students. We funded additional positions for instructional support that provide interventions to increase English language proficiency, reading, mathematics, address social emotional needs, and arts education for all students. Again, we meet regularly with our educational partners through several venues to monitor our efforts and gather feedback.

Our vision and core values are at the heart of all conversations. As additional funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents, and community members.

As noted earlier, we routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners' beliefs that guide our efforts from high-level perspectives to targeted recommendations. Since the pandemic began, we have focused on physical and emotional safety for our students. Throughout this emergency response, we surveyed families (March 2021), conducted virtual meetings with ELAC (March and April 2021), SSC (March and April 2021), students (April 2021), staff (May and June 2021), and administration (August 2021) and corresponded via web-based tools as we prepared to return to in person learning. Our focus groups, listening meetings, and safety talks resulted in articulating the impact of distance learning on families, students, and staff including social emotional issues as well as academics.

It was especially important to ensure our community felt safe returning to in-person instruction. Consequently, we hired additional staff to help with sanitizing facilities. We knew from multiple meetings that our community members were impacted emotionally by the conditions of virtual learning and the pandemic itself. We dedicated time and financial support for increased access to mental health services via counselors, psychologists, outside agencies, and family resources. We worked to mitigate student learning loss through additional support staff, and decreasing small group ratios as well as adding intervention programs, (iReady, Sonday, Zearn, Happy Numbers).

We built a strong distance learning program in SY 20-21 that prioritized social emotional learning, literacy instruction, and small group learning sessions in order to differentiate for student needs. We also built a strong attendance intervention program to support our students and families with class attendance over distance learning. All of our staff and students were provided with the necessary tools to engage in distance learning.

Thanks to the communication and structures we adopted during distance learning, we maintained a comparable attendance rate. We were able to continue communication efforts seamlessly when we returned to in-person instruction and engage our school community continuously. As funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents, ELAC, and SSC. Additionally, distance learning required that we learn, use, and implement technology to enhance instruction. When we returned, we maintained technology tools that enhance in-person instruction and provide consistent intervention, e.g.iReady, Happy Numbers, ZEARN, SeeSaw.

Despite additional funds, the most challenging area is staffing. It is difficult to hire for critical areas already in short supply. Returning to in-person instruction makes it more difficult. The availability of qualified personnel is limited, and many people are hesitant to return to the workforce, thereby reducing the pool of candidates.

Additionally, the substitute pool was difficult pre-pandemic for all districts. The situation is exacerbated by an increase in pandemic related absences. When staff members or their family members get covid, absences are extended until it is safe to return.

As a result, it is difficult to bring some actions to scale, e..g. provide interventions systematically. Consequently, we delineated a timeline of spending funds over the three years allotted. This first year will focus on academic learning loss, social emotional issues, and partnering with educational organizations for temporary support. Once we are post pandemic, we are hopeful that staffing difficulties will be resolved and we can hire qualified staff more easily.

# Plan Summary 2022-23

# **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Aspire Antonio Maria Lugo Academy is home to 410 students and families. To date, we serve students in grades TK-5 with a total of 16 classrooms. Our student population consists of 98% Hispanic, 87% FRL, and 36% MLLs. Currently we are approaching our 96% attendance rate or higher currently standing at 90.5% by implementing initiatives and parent/guardian education. For families with special circumstances the attendance team are meeting regularly and providing individualized support.

AMLA proudly has a very active partnership with parents, which has served to expand our programs and better serve our students. Currently all students participate in Universal Language Blast time, which means that students are given 30 minutes a day (4 x week) to further develop their English Language. Students who are English only or RFEP are also participating in higher-level language development at this time being that we consider all student ACADEMIC language learners. We have also included a Differentiation Block for all students that allows for an intentional focus on foundational skills in reading and writing.

We are also very proud of the efforts made in our social emotional programming, which include the importance of being responsive and focussed on three areas; renew, reunite, and thrive utilizing the CASEL framework. Continue to utilize learnings from our partnership with LACOE to strengthen our emphasis in positive reinforcement for our TIER 1 expectations and curriculum. Furthermore, we have continued to develop our differentiated supports and programming for students in need of Tier 2/3 emotional/behavioral support. In conjunction with this work, our team has also prioritized the work of adult SEL through various adult learning opportunities.

Evidence that this program is successful includes AMLA still proudly holding a zero suspension/expulsion rate. Overall, we feel that at AMLA students are provided with a rigorous and differentiated academic experience as well as the opportunity to cultivate their character and passion through our continuously expanding enrichment programs. At AMLA we believe that all stakeholders are key to college for certain.

AMLA is part of the Aspire Public Schools (APS), a non-profit 501(c)(3). The Home Office of Aspire Public Schools serves AMLA through business services, professional development and other operational support.

# **Reflections: Successes**

We fully returned to campus during this 2021-2022 School Year. Safety was a huge priority for our community including physical, psychological, and emotional. Protocols were put in place along with support for students and families. We attended to differentiating instruction along with staff and students' social emotional needs.

Academic Growth as Measured by Internal Data:

MATH: Metrics from the iReady Math Assessment, between MOY administration and EOY administration, Aspire Antonio Maria Lugo Academy has utilized internal data to measure student growth.

K-2 an average of 43% growth in the percentage of students at or above standard.

3-5, an average of 25% growth in the percentage of students at or above standard.

READING:Metrics from the iReady ELA Assessment, between MOY administration and EOY administration, Aspire Antonio Maria Lugo Academy has utilized internal data to measure student growth.

3-5, an average of 16% growth in the percentage of students at or above standard.

Student surveys:

85% of students have reported that they feel a sense of belonging to school, an increase of 11% from last year.

92% of students feel connected to other students, an increase of 15% from last year.

79% of our students feel connected to at least one adult at our school, an increase of 7% from last year.

Family surveys:

91% of families state that their child is excited to come to school (3% increase).

92% of families feel comfortable discussing their child's needs with their teacher and/or other school staff (1% increase)

91% of families would recommend our school to other families in the community.

We believe that this growth is due to our focus on priority standards and on our planning protocols, as well as our MTSS Data Analysis protocols and direct support of the whole child. By continuing to focus on effective intellectual preparation, as well as consistent monitoring and responding to data, collaborating as teams, and engaging families we will continue to see growth in our internal data.

# **Reflections: Identified Need**

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The strain of the pandemic continues to impact our attendance. Our attendance data has dropped from 95.5% to 90.5% and our chronic absenteeism rate has increased from 13.4% to 33.1%. This directly impacts our instructional program.

Academic Needs: Although we are proud of the academic growth in the percentage of students at or above standard for the 2021-2022 school year, Aspire Antonio Maria Lugo Academy also recognizes that there is still unfinished learning. iReady Math EOY data shows 21% of K-2 students and 28% of 3-5 students are at risk. In reading, for the iReady ELA EOY assessment, 44% of 3-5 students are at risk. To address this we will continue to provide a differentiation block to provide time and space for targeted small group intervention. To address this, we are hiring more instructional assistants who will be able to provide consistent targeted instruction in small groups.

SEL: Many will have experienced trauma as a result of the pandemic. To address this, Aspire Antonio Maria Lugo Academy will continue working with our mental health therapist and our regional office to integrate SEL and play into all of our daily lessons as part of the redesign of our pedagogy. We recognize that when SEL is a separate block, it often emphasizes compliance rather than true social-emotional learning. Our data cycles will also include a holistic view of the child making sure that all needs are being met. Engagement with a new curricular resource as well as continued training in Restorative Practices.

Supporting MLLs: Although our MLLs (ELs) are showing some growth in our internal reading or math, Aspire Antonio Maria Lugo Academy recognizes that supporting MLLs is an area of need, especially in ELA or Math. At Aspire Antonio Maria Lugo Academy our staff consistently disaggregates data in our MTSS Data Talks with a lens for our MLLs, which enables us to track the efficacy of supports and ensure we are seeing consistent academic growth. Although TK-2 had general success in increasing the amount of students at or above standard by 14%, there was only a 2.4% growth among MLL students between BOY administration in October 2020 and MY administration in February 2021. To address this, we will provide professional development around integrated ELD in ELA and focus on strategic planning sessions with TK-2nd grade educators with foundational reading skills in mind.

In addition, in math there was a 17% increase of MLL who performed below and significantly below 2nd grade level from the BOY to the MOY internal assessment. To address this, we will provide professional development around integrated ELD in math and focus on strategic planning sessions with the 2nd grade educators.

Supporting SPED: Our students with disabilities continue to benefit from the inclusion of the Sonday curriculum, Aspire Antonio Maria Lugo Academy will move forward with using the aligned curriculum to better support the foundational needs of our students in reading and writing. We will also base staffing, training, and materials for our special education program on the needs of our students both academically and behaviorally.

# **LCAP Highlights**

As we look and plan for the 2022-2023 school year, here are the actions AMLA will be putting into place to support our students, families, and team members:

This year's LCAP will focus its attention on responding to the learning needs of identified subgroups and preparing for the acceleration of learning for our whole school community. During the 21-22 school year, we recognized the importance of being responsive and focussed on three areas; renew, reunite, and thrive utilizing the CASEL framework. Moving into the 22-23 school year, we are maintaining these areas of focus:

#### Renew:

• All staff members will receive professional development in the area of antiracism from consultants and monthly Professional Learning

• Reading Instruction PD: Teaching staff will receive professional development in the area of reading through a comprehensive line of materials designed to help educators provide multisensory reading instruction to students from pre-K through 8th grade reading levels.

• Renewing a structured, systematic, multisensory reading intervention program for students in the classroom, intervention and special education.

• Redesigning of ELA units to ensure that literature is more diverse and inclusive; staff will also purchase additional books for their classroom libraries to ensure students are provided a more diverse and inclusive range of literature and informational text.

• Purchasing a comprehensive assessment platform to assess student learning in both math and ELA.

• Hiring instructional assistants and a one year on site substitute allowing for teachers to attend professional development, observations, and plan for instruction.

• Intentional coaching and professional learning cycles that are aligned and responsive to student needs

Reunite:

- Purchasing of materials including furniture, books, student manipulatives for intentional spaces
- Hiring additional support for administration and/or interventionist. Continuing with a full time health technician and office assistant with a focus on family engagement
- Staff will engage in Professional Learning around play connecting inside and outside the school setting.

Thrive:

# **Engaging Educational Partners**

At Aspire Antonio Maria Lugo Academy, we believe that engagement from all stakeholder groups is key to the successful implementation of our program. Throughout our LCAP development process, we consulted with the following stakeholder groups: administrators, teachers, non-instructional staff members, students, SSC members, ELAC members, and other parents of our students. Please see below for the various ways in which stakeholders have been engaged:

• Annual Family Survey – This survey was administered in March of 2022. The survey included statements for families to evaluate such as: "The school provides a safe environment for my child," "School conferences and materials better equip me to support my child, at home, with school work," and "I feel welcomed and connected to my child's school."

• Annual Student Survey – This survey was administered in March of 2022 to all students in grades 3-5, and it included statements for students to evaluate such as: "This teacher often takes time to make sure I understand the material," "I feel a sense of belonging at my school," and "People of different cultural backgrounds, races, and ethnicities get along well at my school.

• Annual Teammate Survey – This survey was administered to all staff members in February of 2022. It included questions such as "My manager gives me effective feedback that helps me improve my work," "My principal ensures the admin team deals with student discipline effectively and in a timely manner," and "My principal is the instructional leader at my site."

• SSC and ELAC meetings – Our SSC and ELAC met quarterly this past year on ZOOM, and parents had the opportunity to discuss student growth, successes, and challenges. Parents gave input in start, stop, continue sessions about what supports their children needed, and parents provided feedback on LCAP goals.

• Coffee with the Principal— These meetings took place every month this past year in the morning and early evenings, providing families with the opportunity to give input on the work happening at the school and our LCAP goals for the coming year.

• Staff Meetings – Staff meetings took place twice a month, and staff members consistently analyzed data related to student academic success, attendance, and social-emotional supports and belonging.

• Lead Team Meetings—The leadership team met every week to plan for the leading of professional development for the entire staff, driving decisions around academic and social-emotional supports and needs.

• SELPA- Our regional special education staff routinely consult with SELPA regarding students with special needs.

We will continue to dedicate resources to providing an intervention program with a focus on our scholars furthest from the center. # Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

For Action 1, we did not conduct our PD as intensely as originally planned. Our staff members engaged in data analysis via 4-6 week data talk cycle that included MLLs. Additionally, we focused more on planning time and addressing the needs of the whole child.

We were pleased with our professional development and training sessions around Reading. Despite a mix of in-person and virtual instruction, our staff accessed training virtually and we were able to accomplish professional development in the area of reading through a comprehensive line of materials designed to help educators provide multisensory reading instruction and intervention to students from pre-K through 8th grade reading levels.

For Action 2, we implemented our steps as planned.

For Action 3, we were unable to hire as many instructional assistants as planned for general education. Rather than hiring as many classified staff, we provided stipends, common plan time, and hired substitutes as alternatives to hiring new staff.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

As noted in Prompt 1, we experienced difficult staffing issues, most notably with hiring classified staff. Consequently, we redirected those funds to additional actions as noted above. The difference between budgeted and estimated actual expenditures, therefore, was limited and consequently, so was the difference between planned and estimated actual percentages of improved services.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, provided the means to mostly meet our goal of all "scholars meaningfully engaged in rigorous, standards-aligned, culturally responsive academic programming". We provided multiple curriculum materials to meet the varied needs of our students. We renewed classroom libraries with culturally representative and inclusive books, infused technology for seamless curriculum delivery, and ensured just-in-time interventions with targeted materials, Sonday, Seesaw and assessment monitoring iReady, DIBELS. Implementing varied materials enabled us to fully realize academic content, provide full access to CCSS and ELD materials for English Learners, and ensure all students engaged with standards aligned materials.

Ensuring effective staff also ensures student learning. Staff members engaged in professional learning to optimize the curriculum materials noted above as well as multisensory reading instruction. Whether we were in-person or virtual, we were able to mostly meet our professional development actions.

As noted in Prompt 1, Covid disrupted schedules. We plan to implement Action 4 in conjunction with adopting an NGSS aligned science curriculum.

Staffing was difficult this year. We planned to hire instructional assistants. A national staffing shortage exists and we were not immune from that. We met our staffing actions with limited success. Consequently, we plan to focus on temporary hires.

While we met with success during a very difficult year, we realize there are changes to be made. We added Action #4 as noted above, NGSS curriculum. We also shifted metrics in Measuring and Reporting from STAR assessment to iReady, English Proficiency progress utilizing the ELPAC.

# Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We implemented our Actions with changes. For Action1, we were unable to purchase Classroom Calm Space materials. For Action 3, we were unable to purchase the shade structure or electronic gates due to Covid restrictions. We were unable to purchase electronic gates and shade structure due to additional PPE, more custodial hours, cleaning, disinfection, and COVID restrictions. For Action 5, we reduced our family workshops to quarterly rather than monthly. Consequently, we used the funds to support staff on campus with additional substitutes, stipends and extra hours.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was no material differences in costs.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, support goal 2, to cultivate communities that foster inclusive, joyful, and safe learning environments. Quantitatively, our attendance rate decreased from 95.9% to 90.3% and our chronic absenteeism increased from 3.2% to 32.8%. Covid conditions directly contributed to our level of attendance and chronic absenteeism. Parents cited Covid as the reason for their child's absence and we monitored return dates per CDC guidelines when students were absent due to Covid.

Qualitatively, though, our family coordinator made a difference. The coordinator supported family engagement, communication, and an inclusive environment. Despite Covid complications throughout the year, parent surveys indicate a sense of belonging and connectedness at 89% and safety at 91%.

Our attendance team primarily served to intervene for students academically and behaviorally that mitigated decreases in attendance and increases in chronic absenteeism rates. Our attendance team provided interventions to support students. Parent and student engagement events were limited and virtual.

On a positive note, we worked to rebuild our school climate and culture with outreach to families and specifically to students via SEL practices. Additionally, our parent meetings continued, although virtually, for ELAC, SSC, SARB, and SART meetings.

Last, our SARC reports indicate an exemplary rating for our facility.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As a result of this analysis, we will not be moving forward with staff development in play connecting outside and inside the school setting, Play works, a sub task in Action 2. As noted in prompt 3, we plan to make the family coordinator permanent. Also, survey responses indicate a continued need for social emotional learning and more intense counseling. While our MTSS program included a counselor, we believe an aligned curriculum RULER will be added given survey responses and ongoing COVID conditions impacting students' well-being.

As a result, we added Action 6,RULER Program.

As noted in Prompt 1, we provided a means to continue some of the professional development in Action 2. Planning time was intentionally included in our Professional Learning cycles to allow for development around antiracism and anti bias learning experiences and restorative practices.

Our combined actions supported goal 3, "that all scholars have access to a team of diverse, effective, and thriving professionals who are developed and supported to show up their best and enact culturally responsive and anti-racist practices." Virtual and in-person training and purposeful planning time provided a means to ensure all scholars have access. Our teachers maintained a credential rate of 100% and reported an increase in positive working relationships with parents and families at 100%.

Unduplicated funds will be principally directed to low-income and English Learners, the majority of our student body. The student body is 91% unduplicated students, therefore the needs of English learners and low-income students comprise the needs of the majority of our students and represent the focus of our actions. The funds will be effective in increasing and improving the level of academic support and interventions, professional development, data analysis, SEL supports, and continue to build our robust MTSS system. We will use funds to hire and maintain personnel that oversee programs to increase and improve the support systems students receive.

The Actions highlighted in this year's LCAP are being provided on a school-wide basis and we expect that all students will benefit from the implementation of supports and interventions, PD, support from additional personnel, and the continued implementation and focus on SEL and learning strategies and interventions for our Multi Language Learners.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The minimum proportionality percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all pupils is 38.06%. This proportionality percentage will be met through a combination of targeting the increased LCFF funds towards supports that disproportionately target unduplicated pupils. Each goal's intent is to focus our services toward our unduplicated pupils as we believe centering our work on our students furthest from the center will benefit all students. These services are highlighted by principally directing our actions toward our unduplicated populations, which include improving and increasing our intervention and acceleration services, increasing staff to support SEL and well-being, improving our MTSS programs, and improving the services provided by our Deans, Ed Specialist, Instructional Assistants, Counselors, and Intervention specialists. In addition, Aspire will increase the amount and rigor of the EL professional development provided to teachers enabling all staff to increase their ability to provide a rigorous, culturally relevant, and ELD standards aligned curriculum.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

We know from multiple meetings that our community members were impacted emotionally by the conditions of virtual learning and the pandemic itself. We are dedicating time and financial support for increased access to mental health services via counselors, psychologists, outside agencies, and family resources. We plan to mitigate student learning loss through additional support staff, reducing class size and/or decreasing small group ratios as well as adding intervention programs. As noted earlier, our concentration funds are directed to more personnel for our MTSS and Restorative Practice framework and increased hours for existing staff. Additional staffing enables our efforts to focus on students who are learning English, come from a low income household or are foster youth.

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

- Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)
  - o This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

#### **Contributing Actions Annual Update Table**

  - o This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
  - o If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
