


Budget Overview for the 2022 – 23 School Year

The text description for the above chart is as follows: The total revenue projected for Aspire Richmond Technology Academy is \$9,785,322.00, of which \$5,906,597.00 is Local Control Funding Formula (LCFF), \$2,918,090.00 is other state funds, \$24,000.00 is local funds, and \$936,635.00 is federal funds. Of the \$5,906,597.00 in LCFF Funds, \$1,297,607.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Operating expenses are included, but not limited to, the following: education and physical education materials, conferences & travel, education consultants, professional services, field trips, rent, utilities, food services, management fees (national office, regional office, authorizer, SELPA), insurance, interest, depreciation & amortization, and contributions to reserves.

Our core values of Well-Being, Culture of Belonging, Community Partnership, Agency and Self Determination, and Joy bring our Vision to life and drive our actions each day including obtaining feedback from our educational partners. We routinely obtain feedback in three primary ways- Surveys, Community Forums, District/ Community Group Meetings- to incorporate our educational partners' beliefs that guide our efforts from high-level perspectives to targeted recommendations. All priorities and goals, including LCAP goals and additional funding, were developed within the context of our core values. With additional funding, our needs remain the same but now we can increase efforts through intensity and or frequency.

Specifically, we met with our educational partners, families, staff, and administrator groups in **June**, **August and September 2021** as we prepared to return to in-person learning. During these meetings we solicited feedback, asked for new ideas, and listened to partner concerns about returning to instruction in the context of the ongoing pandemic.

Again, we meet regularly with our educational partners through several venues to monitor our efforts and gather feedback.

Our vision and core values are at the heart of all conversations. As additional funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents, and community members.

Additional staff providing direct services to students will accomplish the following.

- 1. Increase personnel to reduce staff to student ratio in classrooms, especially in early grades and increase the capacity for small group literacy interventions through additional classified personnel. In addition we offered summer literacy enrichment to approximately 30% of our student population. In addition, we hired an additional on site substitute teacher to give students greater consistency in the even their teacher needed to be off campus.
- 2. Increase mental health supports for students, staff and families through hiring an additional mental health counselor and giving teachers time to plan robust social emotional learning in a designated and integrated manner.
- 3. Provide an option for long term independent study for families that did not feel comfortable returning to on campus instruction during the ongoing COVID 19 pandemic.
- 4. Added additional on site administrative support to provide more individualized instructional coaching for teachers with a goal of strengthening core instruction.
- 5. Increased capacity of our custodial team to provide more in depth and frequent cleaning and disinfection of our school campus.

We built a strong distance learning program in SY 20-21 that prioritized social emotional learning, literacy instruction, and small group learning sessions in order to differentiate for student needs. We also built a strong attendance intervention program to support our students and families with class attendance over distance learning. All of our staff and students were provided with the necessary tools to engage in distance learning.

Thanks to the communication and structures we adopted during distance learning, we maintained a comparable attendance rate (96.7% in 19/20 and 95.9% in 20/21. We were able to continue communication efforts seamlessly when we returned to in-person

instruction and engage our school community continuously. As funds became available we used our standing outreach efforts to obtain input from all aspects of our community - staff (June and July 2021), parents (Monthly throughout 2021), ELAC (June and December 2021), SSC (June and December 2021). Additionally, distance learning required that we learn, use, and implement technology to enhance instruction. When we returned, we maintained technology tools that enhance in-person instruction and provide consistent intervention, e.g. Lexia, Happy Numbers.

Despite additional funds, the most challenging area is staffing. It is difficult to hire for critical areas already in short supply. Returning to in-person instruction makes it more difficult. The availability of qualified personnel is limited, and many people are hesitant to return to the workforce, thereby reducing the pool of candidates.

Additionally, the substitute pool was difficult pre-pandemic for all districts. The situation is exacerbated by an increase in pandemic related absences. When staff members or their family members get covid, absences are extended until it is safe to return.

As a result, it is difficult to bring some actions to scale, e..g. provide interventions systematically. Consequently, we delineated a timeline of spending funds over the three years allotted. This first year will focus on academic learning loss, social emotional issues, and partnering with educational organizations for temporary support. Once we are post pandemic, we are hopeful that staffing difficulties will be resolved and we can hire qualified staff more easily.

We built a strong distance learning program in SY 20-21 that prioritized social emotional learning, literacy instruction, and small group learning sessions in order to differentiate for student needs. We also built a strong attendance intervention program to support our students and families with class attendance over distance learning. All of our staff and students were provided with the necessary tools to engage in distance learning.

Thanks to the communication and structures we adopted during distance learning, we maintained a similar attendance rate during our distance learning program. We were able to continue communication efforts seamlessly when we returned to in-person instruction and engage our school community continuously. However, because of stringent quarantine and contact tracing protocols, along with families and staff keeping themselves home when they are experiencing illness, we have not been able to maintain a comparable attendance rate this year. We are tracking about 5% lower than in typical years, and all of this change can be attributed to illness and COVID.

As funds became available we used our standing outreach efforts to obtain input from all aspects of our community- students, staff, parents. Additionally, distance learning required that we learn, use, and implement technology to enhance instruction. When we returned, we maintained technology tools that enhance in-person instruction and provide consistent intervention, e.g. Lexia, Zearn, iReady, mCLASS, MyOn, etc.

Still, return to in person instruction with the benefit of additional funds was not without its challenges. We strive to maintain a balance between the benefits of in person instruction, safety issues, and the social, emotional effects of the pandemic.

Despite additional funds, the social emotional needs of student and staff are of paramount concern and continue to present challenges. Even with the additional mental health and other administrative staff, we continue to feel a need for more counseling and mental health intervention services for our community.

Another challenging area is staffing. It is difficult to hire for critical areas already in short supply. Returning to in-person instruction makes it more difficult. The availability of qualified personnel is limited, and many people are hesitant to return to the workforce, thereby reducing the pool of candidates.

Additionally, the substitute pool was difficult pre-pandemic for all districts. The situation is exacerbated by an increase in pandemic related absences. When staff members or their family members get covid, absences are extended until it is safe to return.

Plan Summary 2022-23

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Aspire Richmond Technology Academy is a direct-funded countywide benefit charter school located in West Contra Costa County. It is chartered through West Contra Costa Unified School District (WCCUSD).

Aspire Richmond Technology Academy has been serving students in the Richmond and San Pablo community since 2015. This school year, we served approximately 500 students. For the 22-23 school year we will serve approximately 540 students in grades TK-5.

Currently, the school's demographic profile is 70% Latino/Latina/Hispanic, 15% African American, 5% Asian, 1% White, 1% Native Hawaiian/OtherPacific Islander, 1% American Indian/Alaskan Native, and 2% multiple ethnicities with 74% of the student body eligible for the free and reduced priced meals program. Forty-four percent of students are classified as English Language Learners and 16% of our students receive Special Education services. Currently, none of our students are Foster Youth and 1% of our students are counted as homeless.

Aspire's vision is that every student is prepared to earn a college degree and was founded to address the long-standing inequities in TK-12 education. Its mission is to open and operate small, high-quality charter schools in low-income neighborhoods in order to: increase the academic performance of historically underserved students, develop effective educators, share successful practices with other forward-thinking educators, and to catalyze change in public schools. Specifically, at Aspire Richmond Technology Academy our vision is Education for Liberation. At Aspire Richmond Technology Academy we strive for excellence. We provide a rigorous education that meets each student's academic and social emotional needs. We collaborate, communicate, problem solve, and critically think through rigorous learning experiences. We all work tenaciously together to cultivate an environment where stakeholders are healthy, safe, engaged, supported and challenged to become transformational agents of change.

Coming back to in person learning proved to be challenging, however, our school community came together and has a lot to celebrate. Our top priority was physical and emotional safety of our students so that they could be in the proper mindset to learn. Social emotional learning and relationship building were extremely important to us and we've seen students make huge strides in their ability to resolve conflict, self-regulate, and are seeing strong growth, particularly in reading.

Our local assessments in reading show that we have been successful in reducing the number of students reading far below grade level and accelerating learning. At the foundational level, we have seen a 10% decrease in the number of students at risk for being below grade level in reading and at the upper grades we began the year with 50% of students reading 2 or more years below grade level and 30% reading 1 year below grade level. Our mid year assessments showed 36.9% and 35.2% respectively. We are excited to see our results in June and our progress monitoring data looks promising as we continue to double down on targeted reading interventions for students.

Based on the review of COVID-19 and Data Reporting at *DataQuest, we are pleased that we continue to fully implement academic standards and provide a broad course of study to all scholars (including theater, PE, and art for all). We have continued to prioritize the development of our educators and maintenance of our facilities in excellent condition. And our open door policy with families has continued to be a point of pride for our community. Specifically, our Educational Partners report on our annual survey that they have strong feelings of connectedness and high levels of safety for their children.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

Since returning to in person instruction, there have been several challenges related to the ongoing global complex trauma of the pandemic.

First and foremost our students have significant mental health needs as evidenced by a large increase in the number of mental health risk assessments and a general need for counseling services. We have seen increases in maladaptive behaviors, but have rallied as a school team to put in strategic supports and interventions for scholars along with dedicated instructional time to teach prosocial coping skills and emotional regulation.

Based on the review of COVID-19 and Data Reporting at DataQuest, we have determined that improvement is needed in the area of attendance and English Language Development. While our school attendance pre-pandemic was generally around 96 to 97%, this year, our average daily attendance rate has been around 87%. This steep decrease has been due to Covid quarantines and isolation as required to keep our community safe. Significant staffing disruptions also do to quarantines and isolations have prevented us from having the people

power to support families in improving attendance. We are looking forward to more level attendance rates as the pandemic shifts to the next phase. We know this is critical to student learning.

While we have seen that our Multi-Language Learners have grown tremendously in their academic skills this year, we know that many lost significant exposure to Academic English during this pandemic. We know that reading and writing in English is fundamental to improving their access to academic content, and we plan to push for more intervention specific for these students next year.

The following are steps that we will take to address the areas in need of improvement:

- 1. We plan to hire a second full time general education mental health counselor and two intern counselors.
- 2. We plan to hire two full time reading intervention teachers to continue improving school wide literacy with a focus on Multi-Language Learners.
- 3. We plan to continue to have a full time Dean of Students and Student Supports Manager to support with a strong school-wide social emotional learning program and school-wide behavioral health.
- 4. To improve attendance, we are planning for strong start attendance team to intervene early in attendance issues and leverage our existing family coordinator to do this work.

EP surveys, community meetings and information sessions, and ongoing correspondence with parents/family members, certificated & classified staff, principals and district administration, Special Education Local Plan Area (SELPA), students, and community partners took place throughout the spring of 2021 and the 2021-22 school year. Across all EP groups, representation from Special Education, English Learners, Homeless & Foster Youth, and

SocioEconomically Disadvantaged Students (parents, staff, and students) were invited to participate and included in input gathering sessions. Specifically for the purpose of revising the LCAP, additional EP conversations and presentations took place at committee meetings such as School Site Council, English Learner Advisory Council, Monthly Admin Chats, and weekly staff meetings.

A community wide LCAP EP survey was conducted in March to collect input for the 2021-22 LCAP annual update.

Input gathering sessions were held throughout the year:

We also conducted a large scale student LCAP survey. In student-friendly terms, students were asked to rate and comment on aspects of our 2021-22 LCAP goal areas that are of most interest and relevance to them. Approximately 200 students in Grades 3-5 completed the survey, with feedback submitted in each of the three sections: Academic Achievement, Environment and Learning Conditions, and Climate and Engagement. The data will be reviewed over the summer and shared for site and district analysis early into the 2022-23 school year. Based upon initial observation and feedback from teachers who were present before/after students completed the survey, there was a general appreciation and liking by students in being given the opportunity to share their input. Continual evaluation of the input during this COVID-19 schools closure and distant learning period has provided crucial information, insight, and perspective on the needs and services that bring support and/or barriers to student learning and overall success. The collective experience and the expectations of anticipated needs as a result, play a significant factor in the reviewing of goals and revising, as needed, of focus areas, actions and services.

Aspire Richmond Technology Academy is proud of the EP input process used to guide the review and updating of our LCAP. Parents, leadership, teachers, staff, students, and the Board of Trustees all have opportunities to provide input to the LCAP Annual Update through committee meetings, consultation meetings, site meetings, Board meetings, and surveys.

A summary of the feedback provided by specific educational partners.

Although, feedback from all groups was generally positive as it relates to stakeholder experience at Aspire Richmond Technology academy, we saw clear trends with feedback from all educational partners. All stakeholder groups aligned on the following themes:

• Focus on safety and protocols procedures related to the COVID19 Pandemic.

- The need for us to focus on social emotional learning for all community members
- A wish for more robust mental health supports for students
- Academic accelerations particularly around reading and mathematics.

In summary, families had a strong interest in increasing the number of adults on campus in order to support students academically and emotionally. Staff shared an interest in continuing our strong blended learning program to target academic support for students and asked for an investment in targeted reading intervention curriculum. Families and staff both specifically asked for increased mental health services for students. Admin and lead teachers shared an interest in more differentiated support for teaching staff with our newest teachers receiving more targeted coaching from our admin team. Finally, across all groups, there was sustained interest in continuing our staff committees for heritage months and staff affinity groups. We also saw an interest in refining our student intervention referral process and increasing the amount of reading intervention available to students.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

From the feedback above, our LCAP was influenced in the following ways:

Increasing the amount of support staff for the 22/23 school year, specifically an increase in campus monitors to support student safety on campus.

Increasing to two FTE reading interventionists to provide mores support.

Continued use of blended programs to target intervention (Lexia, MyOn, Zearn, Reflex, and Happy Numbers) in order to provide just right intervention and build in time for teacher run tier two intervention.

Continued use of the SIPPS curriculum for tier 2 and 3 reading intervention and the purchase of the expanded curriculum.

An addition of a 2nd full time mental health counselor

Continued dedicated time and financial support for heritage month celebrations.

As we returned to full re-opening for the school year 2021 - 2022, it was vital that we focused on in-person instruction that was not only rigorous, but standards aligned and culturally responsive in order to accelerate learning for our scholars. Throughout the 2021-2022 school year, we heard from our stakeholders that when we return to in-person instruction, scholars will need extra support to accelerate learning from a year of online instruction. We will dedicate resources to providing an intervention program with a focus on our scholars furthest from the center. We will accelerate learning opportunities through rigorous standards aligned instructional guidelines in addition to adopting science and history curriculums. The intention of this goal and all goals found in this year's LCAP, is to transform the disproportionate outcomes we see in our education systems, and which were exacerbated by the disproportionate learning loss and trauma experienced during the pandemic.

When combined with our organizations' anti-racist Core Values, these Goals and Actions will drive us to achieve greater racial, social, and gender equity across our school and communities.

Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We have adhered to the action plans in the above goal area. Due to the pandemic, we experienced staffing challenges and were unable to hire a Reading Interventionist. In addition, we implemented a school-wide reading program to incentivize choice reading including the opportunity for students to earn books as they meet their goals.

We are satisfied with our staff professional development and training plan. Instruction was primarily in person, however much of our professional development took place virtually this year. We were able to cover all training plans related to MLL, Foundational Skills, Mathematics, and academic acceleration.

Continued training, whether virtual or in person, was successful as evidenced by an increase in local assessments that showed an increase in students performing at or above grade level (see above) from beginning-year to mid-year outcomes despite conditions due to Covid. Still, Covid disrupted schedules for integrated and designated ELD as well as systematic interventions for all students. For safety reasons, we were unable to combine cohorts of students into designated ELD programs and provide systematic interventions in a consistent way.

Our continued use of Wit and Wisdom and Eureka Curriculum along with prioritizing common planning time for teachers has had a positive impact and we believe that it has mitigated further learning loss.

Along with other districts, we continue to experience difficulties related to hiring and staffing. We have leveraged stipends and expanded hours in order to ensure students have access to properly credentialed teachers for all instructional time.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

As noted in Prompt 1, we experienced difficult staffing issues, most notably with the Reading Interventionist position and with many staff absences related to COVID quarantine and exposure. Consequently, we directed those funds to additional actions and provided stipends (Action 1.7) for existing teachers and extended hours for classified staff. The difference between budgeted and estimated actual expenditures, therefore, was limited and consequently, so was the difference between planned and estimated actual percentages of improved services.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, provided the means to partially meet our goal of all "scholars meaningfully engaged in rigorous, standards-aligned, culturally responsive academic programming". We provided multiple curriculum materials to meet the varied needs of our students. We

renewed classroom libraries with culturally representative books, infused technology for seamless curriculum delivery, and ensured just-in-time interventions with targeted materials, SIPPS, Wit & Wisdom, Eureka Math and assessment monitoring iReady and Dibels. Implementing varied materials enabled us to fully realize academic content, provide full access to CCSS and ELD materials for English Learners, and ensure all students engaged with standards aligned materials.

Ensuring effective staff also ensures student learning. Staff members engaged in professional learning to optimize the curriculum materials noted above as well as designated and integrated ELD, anti-racism, research based reading instruction, and dedicated collaborative planning time. Whether we were in-person or virtual, we were able to meet our professional development actions.

As noted in Prompt 1, Covid disrupted schedules.

Staffing was difficult this year. We planned to hire intervention specialist, but a national staffing shortage exists and we were not immune from that. We met our staffing actions with limited success. Consequently, we plan to focus on temporary hires, partner with education organizations, increase technology enhanced instruction and provide virtual targeted blended learning.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

While we met with minimal success during a very difficult year, we realize there are changes to be made.

We plan to implement Action 1.12 in the 22/23 school year in conjunction with adopting an NGSS aligned science curriculum. Providing training and intervention via content areas for English Learners has proven to be very successful.

We also plan to implement action 1.13 in the 22/23 school year. By increasing our intervention team to 2 FTE we expect to be able to provide more intensive support to scholars that are reading below grade level and consequently increase academic access.

Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Covid has continued to cause unprecedented disruptions to school operations, particularly in the area of culture and climate. While we have returned to in person instruction, covid quarantines have removed the predictability and consistency that have historically been pillars of our school model. Additionally, we have been unable to host large group gatherings and community building events for our school community. While we have done our best to hold these events online through zoom, participation has been significantly lower than in previous years.

The above has had a significant impact on student social emotional wellbeing as evidenced by an increase in mental health needs and maladaptive behavior and decreases in attendance. These areas have taken greater priority and have required more intense efforts that we initially planned for. Students struggled with Covid conditions and often came to school having been personally impacted by Covid deaths or

exposures. We increased social emotional learning time, further committed to our school wide mindfulness initiatives, and reallocated staff to focus on supporting student supervision during unstructured times like recess and lunch.

We struggled to maintain a robust MTSS program on our campus due to staffing shortages and the need for on campus administrators to cover classes and cover positions that were out on covid quarantine or unfilled.

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions, together, support goal 2, to cultivate communities that foster inclusive, joyful, and safe learning environments. Quantitatively, our attendance rate decreased from 95.9% to 87.4% (As of April 1) and our chronic absenteeism increased from 11.5% to 53.3%. Covid conditions directly contributed to our level of attendance and chronic absenteeism. Parents cited Covid as the reason for their child's absence and we monitored return dates per CDC guidelines when students were absent due to Covid. 95% of families reported consistency in communication when students were absent or tardy to school.

From our LCAP survey, we saw the following: despite Covid complications throughout the year, student, staff and parent surveys indicate a sense of belonging (77%) and connectedness (81%). The vast majority (95%) of families reported feeling that the school leadership actively seeks input when making decisions regarding the school community and 100% of families reported that their children feel safe and welcomed at school.

Due to staffing inconsistencies with staff being placed on covid quarantines, we found that we needed our administration team to focus on covering classrooms and supporting with student safety during recess, lunch, and other unstructured time. Interventions were administered in a less robust way than planned and our MTSS team did not meet as frequently as plannedWe were able to examine data quarterly and plan for and implement some intervention services, but we were not able to meet our goal of more thoroughly supporting teachers in thinking through tier 2 supports for their classroom.

Parent and student engagement events were limited, however, on a positive note, we worked to rebuild our school climate and culture with outreach to families and specifically to students via SEL practices. We were able to provide targeted professional development in RULER, social emotional learning, culturally responsive teaching, crisis intervention and restorative practices through virtual training. Additionally, our parent meetings continued, although virtually, for ELAC, SSC, SARB, and SART meetings.

Last, we hired additional custodial staff to manage the added cleaning time and costs and updated our facilities with outdoor furniture. Our SARC reports indicate a satisfactory rating for our facility.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

We added two Actions 2.11 and 2.12. As mentioned above, the mental health needs of students have greatly increased due to the pandemic. Additionally, survey responses indicate a continued need for social emotional learning and more intense counseling. While our MTSS team included a counselor, we believe *two full time Gen Ed* counselors are warranted given survey responses and ongoing COVID conditions impacting students' well-being. We plan to increase the number of FTE Mental Health counselors on site and support our clinicians in bringing in two mental health interns to increase the amount of mental health supports provided to our community.

In addition, we plan to partner with community organization Playworks. This partnership will train our staff on active recess and support our students having more pro-social interactions during recess time.

Alongside a focus on our scholar's academic, emotional and social well-being, we also wanted to create a goal that focused on our staff. We will continue to develop our teachers and site leaders through the Aspire Student Learning Framework and the Transformational Leader Framework. While it is necessary and more important than ever to focus on the social emotional learning of our scholars, it is also pivotal that we support the social emotional needs of our staff in order for them to show up and be their best selves every day for our scholars.

The intention of this goal and all goals found in this year's LCAP, is to transform the disproportionate outcomes we see in our education systems, and which were exacerbated by the disproportionate learning loss and trauma experienced during the pandemic. When combined with our organizations' anti-racist Core Values, these Goals and Actions will drive us to achieve greater racial, social, and gender equity across our school and communities.

Goal Analysis for 2021-22 LCAP Year

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were able to successfully implement all of the above planned actions with the exception of action 1. While we initially planned to host on site affinity groups, the unanticipated mental health needs of staff and students required us to reallocate professional development time to meet those needs. We did prioritize participating in regional affinity groups quarterly.

Throughout much of the year, we continued to leverage virtual settings for professional development in order to keep our staff safe and to minimize covid exposure and resulting quarantines. As we move to the end of the year, more of our professional development is taking place in person and we are seeing stronger connections between staff.

We implemented quarterly feedback cycles for PD during which our leadership team composed of grade level teachers, ed specialists, and admin provided candid feedback on the PD sequence from the previous quarter and planned the PD calendar for the next quarter. Based on this feedback, we reduced the number of who staff PD's giving more time for teams to collaborate on planning and interventions based on data. Overwhelmingly, this had a positive impact on staff feeling supported and able to have more sustainability in their work.

There were no material differences between budgeted and estimated actual expenditures.

Our tiered professional development and coaching have been very supportive of our teachers, particularly our newest teachers. All of our first and second year teachers plan to return for the 22/23 school year.

We continue to pursue our actions in Goal 3 and have not changed goals, metrics, or actions.

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Unduplicated funds will be principally directed to low-income and English Learners, the majority of our student body. The student body is 87% unduplicated students, therefore the needs of English learners and low-income students comprise the needs of the majority of our students and represent the focus of our actions. The funds will be effective in increasing and improving the level of academic support and interventions, professional development, data analysis, SEL supports, and continue to build our robust MTSS system. We will use funds to hire and maintain personnel that oversee programs to increase and improve the support systems students receive.

The Actions highlighted in this year's LCAP are being provided on a school-wide basis and we expect that all students will benefit from the implementation of supports and interventions, PD, support from additional personnel, and the continued implementation and focus on SEL and learning strategies and interventions for our Multi Language Learners.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The minimum proportionality percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all pupils is 20.6%. This proportionality percentage will be met through a combination of targeting the increased LCFF funds towards supports that disproportionately target unduplicated pupils. Each goal's intent is to focus our services toward our unduplicated

pupils as we believe centering our work on our students furthest from the center will benefit all students. These services are highlighted by principally directing our actions toward our unduplicated populations, which include improving and increasing our intervention and acceleration services, increasing staff to support SEL and well-being, improving our MTSS and PBIS programs, and improving the services provided by our APs, Ed Specialist, Instructional Assistants, Counselors, and Intervention specialists. In addition, Aspire will increase the amount and rigor of the EL professional development provided to teachers enabling all staff to increase their ability to provide a rigorous, culturally relevant, and ELD standards aligned curriculum.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

As noted above, our plan to increase personnel for mental health services and for academic intervention will directly support our students who have increased academic social emotional and academic needs and adverse childhood experiences. This additional staffing will allow us to focus our efforts on students who are learning English, come from a low income household or who are foster youth.
